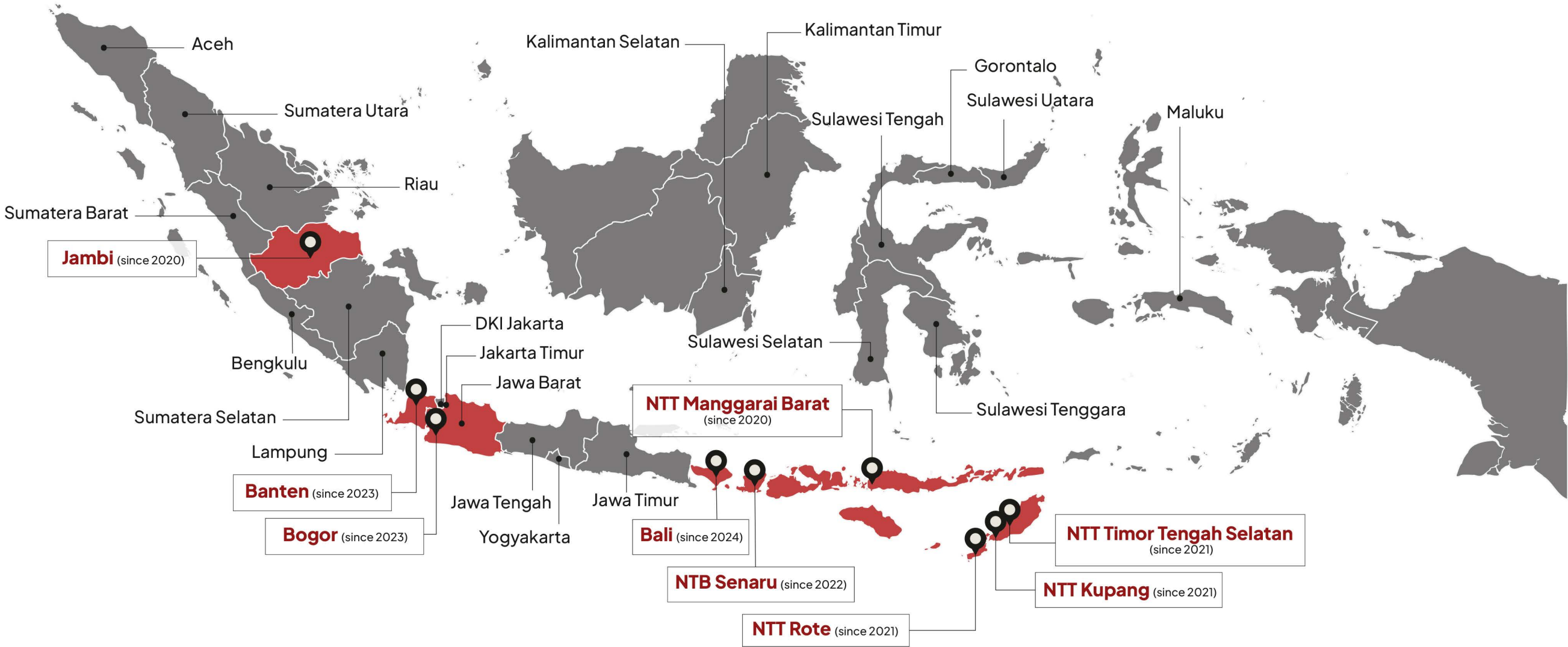

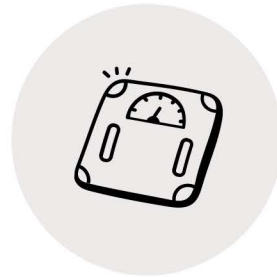

Minister of Health Pushes 1000 Days Fund to Scale

Following three years of dedicated effort, the 1000 Days Fund had the distinct honor of presenting its scaling strategy to **Budi Gunadi Sadikin, Minister of Health of the Republic of Indonesia**.

This pivotal meeting centered on three key requests:

1. **Endorsement of the 1000 Days' Blended Training Module:** Formalizing the skills of Indonesia's 1.5 million community health workers.
2. **Policy Formalization Witness:** Joining Board Emeritus Andy Noya to commemorate the signing of a district-level policy in Manggarai Barat, NTT, solidifying support for frontline CHWs.
3. **Collaborative Pilot Program:** Co-designing a pilot initiative to halve the incidence of low birth weight babies among pregnant women.

Minister Sadikin's decisive and enthusiastic support was immediate, paving the way for significant advancements:

- **National Training Integration:** Commitment to feature our training materials on the Ministry's website with official endorsement by January 2025.
- **Provincial Policy Advancement:** Support for a provincial-level policy in NTT, with a commitment to convene key stakeholders, including Andy Noya and Governor Melki, for a collaborative strategy session.
- **Expanded Pilot Initiative:** Agreement to extend the low birth weight reduction pilot across three islands in NTT: Timor, Flores, and Sumbawa, amplifying the program's reach and impact.

1000 Days Fund Joins RCT Stakeholder Meeting in Rwanda

The 1000 Days Fund's participation in the Rwanda RCT stakeholders meeting, hosted by the Elsa Miller Foundation, highlighted its strong commitment to evidence-driven innovation in reducing stunting. The Fund had the unique opportunity to engage alongside global experts such as Robert Black and Zulfiqar Bhutta (1000 Days Fund's Research Advisory Board) to discuss scalable interventions. Central to these discussions was the "Goldilocks Challenge" framework, which emphasizes finding the right balance between localized adaptability and systemic rigor.

The Goldilocks Challenge framework draws its name from the classic fairy tale, where Goldilocks seeks options that are "just right" – neither too much nor too little. Applied to social programs, this framework guides organizations to develop evidence and monitoring systems that are credible, actionable, responsible, and transportable (the CART principles). It encourages finding the "just right" fit for evidence collection and evaluation that suits the specific context and stage of a program, avoiding overly complex or insufficient data approaches. This balance ensures that interventions are both effective and scalable, while remaining adaptable to local needs.

At the meeting, key outcomes included optimizing health worker training protocols, integrating real-time data dashboards, and aligning cross-sector efforts to meet Indonesia's stunting reduction targets. By prioritizing empirical accountability and iterative learning, the 1000 Days Fund sharpened its focus on solutions that are both context-specific and scalable—such as empowering community health workers—while reinforcing its role as a bridge between grassroots innovation and national policy.



Partnerships & Funding

1000 Days simultaneously lives within the boundaries of government-run data initiatives, while at the same time employing an internal compass to gauge "real data" that represents the reality of populations served

Our fundraising strategy seeks to guarantee the necessary annual dollar amount to achieve organizational goals for 3–5 years (in order to allow for focus on the actual work, rather than fundraising for the work).

Smart Chart Adoption

In 2024, the 1000 Days Fund continued its collaboration with Mercy Corps in Timor Leste and the Zuellig Family Foundation in the Philippines to support the adoption of Smart Charts in these countries. Building on this progress, our 2025–2027 strategy aims to replicate this successful model by expanding partnerships with additional organizations both within Indonesia and internationally. Through these efforts, we hope to scale the impact of Smart Charts, enabling more communities to benefit from stunting prevention.

Johnson & Johnson Foundation

The 1000 Days Fund, supported by the Johnson & Johnson Foundation, is expanding its team to sustain programs in East Nusa Tenggara and West Nusa Tenggara. The initiative targets health inequities by training and connecting CHWs through its Kader Academy, addressing stunting and malnutrition among children caused by inadequate maternal nutrition knowledge, poor antenatal care, and limited access to clean water. In five districts, 8,700 CHWs serve 68,467 mothers. By empowering CHWs with skills and formal connections to primary healthcare centers, the program aims to reduce stunting rates and improve maternal and child health outcomes.

1000 Days Fund is committed to advancing peer-reviewed evidence that supports and strengthens Indonesia's CHW system. In 2024, we worked in collaboration with leading experts and research institutions, we prioritized the production and publication of rigorous studies and technical papers that inform our approach and drive innovation in stunting prevention. By grounding our programs in robust data and scientific analysis, we ensure that our interventions are effective, empowering CHWs across Indonesia to deliver measurable impact in maternal and child health.

One Term to Transform: Universal Health Coverage Through Professional Community Health Workers

Global health workers shortages demand action. Professional CHWs (proCHWs) offer a transformative, cost-effective solution to achieve universal healthcare. Skilled, salaried, and well-supported, proCHWs save lives, boost economies, and ensure access, even during crises. National proCHW programs are feasible with resources and political will, empowering ministers to rapidly strengthen health systems.

Professionalization of Community Health Workers: Time for A Formal Contract

Community health workers (CHWs) are vital to effective primary healthcare, yet often lack adequate support. While skilled, supplied, supervised and salaried CHW programs ("proCHW") enhance healthcare access, this study proposes adding 'security' – formal contracts – to that framework. Currently, many CHWs volunteer without contracts, risking arbitrary replacement. Formal contracts offer legal safeguards, ensuring fair employment with minimum wage and career paths. Securing CHW contracts requires political will, public-private partnerships, and tailored funding strategies aligned with local administration. Sustainable funding maximizes CHW program impact, strengthening primary care worldwide.

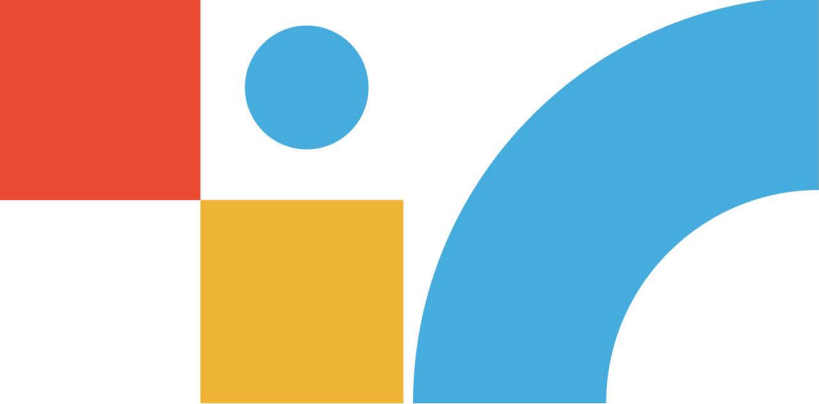

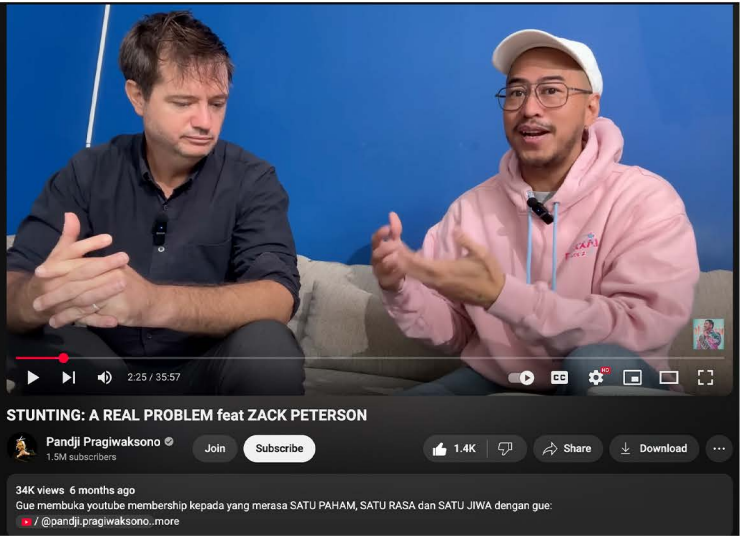
Strengthen Influence

Becoming the First Indonesian Member of the Community Health Impact Coalition (CHIC)

We are the first Indonesian member of the Community Health Impact Coalition (CHIC), a global movement to professionalize community health workers (CHWs). By implementing CHIC's "5S" framework—**salaried, skilled, supplied, supervised, and sustained**—we advocate nationally and locally to empower CHWs, strengthen healthcare systems, and improve health outcomes across Indonesia.

Rote Regent Regulation

1000 Days Funds' contribution to the development of the Regent Regulation Number 68 of 2024 serves as the legal framework for the Integration of Primary Services (ILP) in the region.

1. **Legal framework** for 25 basic skills of CHWs at the regional level.
2. **Strengthening CHWs** through selection processes, training, supervision, and providing appropriate incentives based on their workload and skills.
3. **Budgeting village funds** for disease management efforts, including stunting.
4. **Enhancing health education** through innovative media such as Smart Charts and Smart Blankets.



1000 Days Fund Releases Their Documentary

Set in Labuan Bajo, Indonesia's **Silent Emergency: Stunting in Rural Populations** is a compelling short documentary that explores the alarming prevalence of stunting in Indonesian rural communities, particularly in East Nusa Tenggara. Through personal stories, expert interviews, and vivid on-the-ground footage, it highlights the devastating effects of stunting on children, families, and the nation. The film also showcases the impactful work of the 1000 Days Fund in empowering community health workers to combat this crisis. Winning the **2024 Inspiring Award at Inspiring Asia**, it calls for urgent nationwide action to address this silent emergency.

Government Relations

We highly value our strong collaborations with the Ministry of Health and the Ministry of State-Owned Enterprises, whose continued support has been vital to our achievements in 2024. Key highlights include a visit from Pak Erick Thohir to our booth at the Yayasan BUMN event, as well as meaningful engagements with Ministry of Health representatives alongside our community health workers in Cibungbulang.

Prove the Model

Community Case Management of Stunting

Community Case Management (CCM) of stunting was first piloted in Cibatok 1 Village, Bogor, in August 2023, thanks to the generous support of Yayasan Pelayanan Kasih A&A Rachmat, Yayasan Adaro Bangun Negeri, and Infokes Indonesia. This program features a targeted approach to home visits, where community health workers conduct monthly visits to malnourished and hypertensive pregnant women to prevent low birth weight births. Given that low birth weight contributes to 20% of stunting cases in Indonesia and South Asia, this intervention is critical. Over the course of a year, we reached 901 beneficiaries, achieving a 69% reduction in low birth weight cases (from 37.5% to 11.5%) in Cibatok 1 Village. Building on this successful pilot, we are now replicating the CCM model across East Nusa Tenggara.



Enhance Quality of Research

Research Advisory Board

In 2024, guided by our focus on increasing evidence-based programs and advocacy, we created our first Research Advisory Board. The RAB members comprise global experts in child health, growth development, and program monitoring & evaluation. Chaired by Fred Carden and Yanuar Nugroho, the RAB conducts two meetings per year that have resulted in the development of three studies: case study, implementation research study, and our RCT. We also collaborate with these members to produce more proCHW evidence and continuously develop our M&E framework to match the most updated evidence.

Case Study

In 2024, we launched a case study which aims to scientifically assess our contributions to the stunting prevalence reduction in Rote Ndao & Manggarai Barat compared to other districts. With Elizabeth Pisani, an epidemiologist with over 20 years of experience at the helm, we expect the results to be available in 2025.

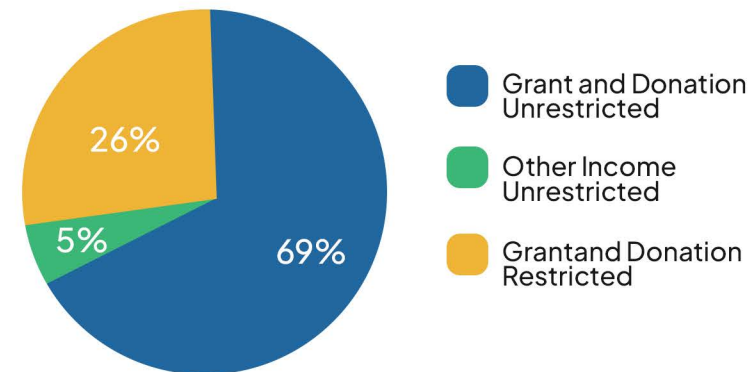

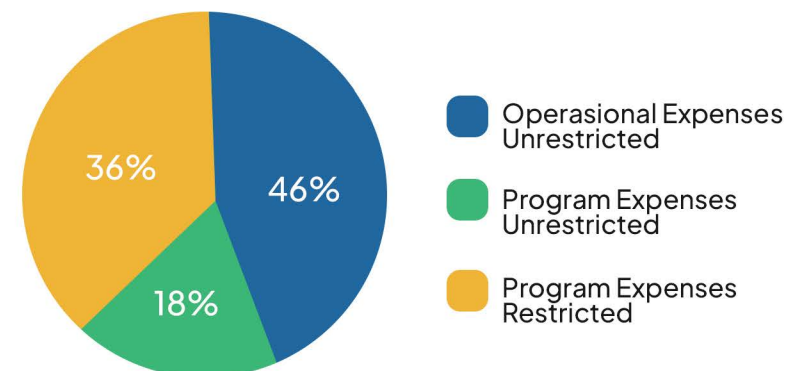
